Robert Barelkowski is Associate Professor at the Institute of Architecture and Town Planning, Faculty of Technology, University of Economy, Poznan. He focuses on interdisciplinary approaches to architecture and town planning.

Graeme Evans, PhD MA, is Professor of Urban Cultures and director of the Cities Institute at London Metropolitan University. He has undertaken national and international research projects into Creative Spaces, Cultural Planning and Culture & Regeneration for cultural ministries, agencies and the OECD. His publications include *Cultural Planning: An Urban Renaissance?*, *Designing Sustainable Cities* and over 75 journal articles and book chapters.

Mia Geijer holds a PhD in History of Architecture from the Royal Institute of Technology in Stockholm. She has also studied restoration and preservation at the Royal College of Fine Arts in Stockholm. She works as an officer of conservation at the Örebro County Administrative Board and is a board member of the Swedish Restoration Society.

Mattias Legnér, PhD in History, is an Assistant Professor at the Department of Integrated Conservation at Gotland University in Visby, Sweden, where he teaches and is head of science at the department. He has been a visiting scholar at Johns Hopkins University, studying historic preservation in American cities, and has also been researcher at Linköping University and Stockholm University. He has also worked in projects for the regional development agencies of the Swedish counties Östergötland and Skåne. He is the author of papers on the challenges of reusing historic buildings in urban development, most recently the report *Historic Rehabilitation of Industrial Sites* (2009).

Randall F. Mason is an Associate Professor in the Graduate Program in Historic Preservation and the Department of City & Regional

Planning at University of Pennsylvania's School of Design. While teaching full-time, he maintains a practice as a planning/preservation consultant and researcher. He worked previously at the Getty Conservation Institute, University of Maryland and Rhode Island School of Design. Recent books include *Giving Preservation a History*, with Max Page (2003), and *The Once and Future New York, on the origins of historic preservation in New York City* (2009). Recent research and professional projects include cultural landscape reports and community-based projects for sites in Philadelphia, New Mexico, New York and Nassau.

Oli Mould, PhD, previously Senior Analyst, Creative Industries Observatory, University of the Arts London.

Ronan Paddison is Professor of Geography at the University of Glasgow. He has researched and published widely in the politics of urban and regional change. Besides continuing to research how public participation is brought into the process of local regeneration, including the installation of public art, he is also working on a project exploring how public space can be engineered to foster inter-cultural dialogue in the multicultural city. He edits two academic journals, *Urban Studies* and *Space and Polity*.

Davide Ponzini, PhD, is Assistant Professor in Urban Planning at Politecnico di Milano. His research activity focuses the role of cultural policies in urban transformation and local development, and urban planning and policy tools. He was visiting scholar at Yale University, Johns Hopkins University and Columbia University. Author of *Il territorio dei beni culturali* (2008), regarding the privatization of cultural heritage in Italy, and of several articles published in Italian and international scientific journals.

Owe Ronström is a professor of ethnology at Gotland University, Sweden. He has written extensively on traditional and popular music, dance, ethnicity, multiculture, age and heritage. Among his recent books are *Kulturarvspolitik* (Heritage Politics, 2008) and *Music*,

Media Multiculture (2003, co-authors Dan Lundberg and Krister Malm). He is currently researching cultural representations of islands, focusing on islands in the Baltic Sea.

Simon Roodhouse is Professor in Creative Industries at the University of the Arts, London, Adjunct Professor of Creative Industries, University of Technology, Sydney, and Director of Safe Hands (Management) Ltd a strategic consultancy engaged in education and creative industries.

Lennart Runesson, PhD, Assistant Professor and Head of Human Geography and Geography at Gotland University in Visby, Sweden. His interest in recent years has been in the field of urban planning problems and the built heritage.

Lukas Smas is PhD and researcher at the Department of Human Geography, Stockholm University.
